Our process is fast and efficient. Without the need to wait for documents to arrive in the USA, the IRS can begin processing ITIN applications as soon as possible.

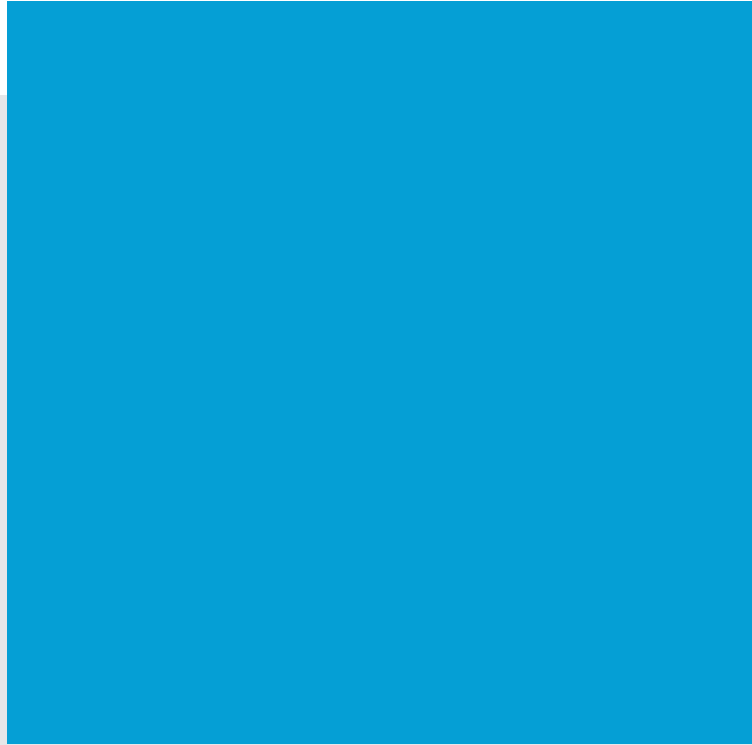
Convenient
